## **Sports Reports:**

**Lacrosse:** Eddie Lozano

Season ended last month. 75% of equipment turned in. \$100.00 in equipment rental.

We concluded our spring soccer season this past weekend. For the most part, everything went smoothly and without issue... except for the Palmer Soccer commissioner miss calculated the Spring EPYSA fees. I included all the player fees, however, I forgot to add the team fees. So that will be a Motion (I'll hold all the motions to the end). BMYSL will return our original check and we will submit a new one. I have not completed the spring season budget, however, I have all of our expenses. I'd like to request the final revenue report from the spring soccer registration so that I can provide the final budget numbers. My estimate is that we should show a profit of approximately \$10,000.

Registration is going very well. We are just under 250 members at this point. We are quickly closing in on our fall 2020 registration numbers. Since BMYSL extended its due date for team commitments I've extended our registration window until August 1. From a coaching perspective, I will be recruiting for 2 coaches at the U9 level and 1 at the U11 level. We will minimally have the same number of teams as we had last fall (14). We have inventoried all our uniforms and it looks like we will need to replace the older age groups (U13 thought U19). It appears that we can get one more year out of our current uniforms for the U9 and U11 age groups.

## Soccer Pre-Season Tournament

Current plan is to have 3 locations: Chrin, Keystone and Mill Race. Potentially looking to work with a food trucks at some of the sites to receive a percentage of the revenue generated. Final details will depend on number of teams registering.

8. Soccer Equipment: Not to exceed \$2,400
  - a. Goal Nets: Set of U11, 2 sets of Large Sided
  - b. Corner Flags: Set of 4
  - c. Game Balls: 12
  - d. First Aid Kits and Ice Packs
